for this purpose, this document indicates the main guidelines to be referred to in Sirples.

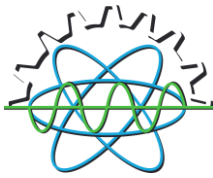
Our commitment is:

- comply with all applicable environmental protection laws and comply with other stakeholder compliance obligations;
- involve all levels of management in order to monitor and enforce environmental protection laws, and implementable internal regulations;
- sustain that environmental impacts are contained over time by adopting advanced technical standards, knowledge and techniques as far as possible;
- develop new products and processing cycles, or the improvement of established ones, always taking into consideration environmental requirements even when not expressly stated;
- cultivating over time a proactive culture aimed at achieving safe behavior and attitudes on the part of personnel in terms of environmental protection:
 - containing water consumption by using special valves connected to taps (so-called “aerators”), and not introducing its use in production processes;
 - use energy-efficient appliances (LED lights, PCs, etc.);
 - avoid energy waste (unnecessary lights on, thermostats with temperatures too different from the environmental ones, machinery left on after working hours or if not needed, etc.);
 - proper disposal of waste (sorting by type) while trying to contain its volume;
 - using packaging that is as recyclable as feasible and reusing it wherever possible;
 - if there is a need to use chemicals they must be managed responsibly in order to avoid accidents of any kind.
